1. Papua New Guinea is a young developing country. 1870's that the first white man ever set foot on the island. people resembled those that of Guinea in Africa. landed on the Rai Coast near Madang. in 1872. abandoned in 1852 because of difficulties. and no government was on the Island. his group of teachers landed at Katau and at Manumanes.


